4	TERMS OF REFERENCE – LOYALIST COLLEGE COUNCIL	
	As Chair of College Council, Governor Kelleher declared a conflict of interest.	
	As a requirement of the Ministry Policy Binding Directive - Governance and Accountability Framework, the College Council was established to provide means for students and staff of the college to provide advice to the President on matters of importance to students and staff. The Board of Governors is responsible for ensuring that the structure, composition and terms of reference for the council are established in the College's By-Laws.	
	In a continued effort to strengthen the Board of Governor's Framework, the terms of reference for the Loyalist College Council was reviewed to ensure it aligned to the requirements set out in the Ministry Policy Binding Directive.	
	An updated Terms of Reference was presented to governors at the September 25, 2019 Board meeting. The mandate was updated and the membership reviewed to ensure representation from all relevant areas of the College community (including students), minimized any potential conflict of interest and aligned with all legislations and directives.	
	The updated College Council Terms of Reference will replace Appendix 3 in the Loyalist College By-Laws.
