Loyalist College Board of Governors

Loyalist College is an important contributor to the productivity of our region. As the public, credentialed post-secondary institution serving nearly 200,000 citizens of Eastern Ontario, Loyalist has a significant economic impact on the region's economy.

Loyalist College is governed by a Board comprising of 17 individuals: 12 external Governors who reflect the communities served by the College; four internal Governors representing Students, Faculty, Support Staff and Administrative Staff, plus the President.

Board members bring unique and diverse perspectives and leadership experiences to their role. Loyalist is responsible for ensuring that its Board of Governors has the necessary skills and experience to govern Loyalist, and that the Board reflects the breadth, depth and diversity of the communities served by Loyalist College including the demographic, cultural, linguistic, economic, geographic, gender, ethnic and social characteristics of these communities.

The recruitment of prospective Board members to fill vacancies as they arise is conducted as needed. Individuals who are familiar with the role of postsecondary education in Ontario and specifically the role of colleges, and who feel that their skills and experience qualify them to be effective members of the Loyalist College Board of Governors, are invited to submit their application.

A new provincial process for appointing external board members to college Boards of Governors came into effect on October 1, 2010. The new appointment process, set out in Ontario Regulation 34/03, has college boards directly appointing two-thirds of their external board members with the remaining one-third of external members appointed by the province through Lieutenant Governor in Council (LGIC) process. The new application/review/appointment process for external members is extensive and is handled through Ontario's Public Appointment Secretariat (PAS).
